



Release and Waiver of Liability for Minors

(Please read carefully! This is a legal document that affects your legal rights!)

This Release and Waiver of Liability (the "Release") executed on this ____ day of _____, of 20__ by _____, a minor child (the "Volunteer"), and _____, the parent having legal custody and/or the legal guardian of the volunteer (the "Guardian"), in favor of Sobo Central, a non-profit corporation of the state of Maine, their trustees, directors, officers, employees, and agents (collectively "SoBo Central").

The Volunteer and Guardian desire that the Volunteer work as a volunteer for SoBo Central and engage in the activities related to being a volunteer (the "Activities"). The Volunteer and the Guardian understand that the Activities may include setting up for, participating in and cleaning up after the Lanternfest 2011 and said Activities may occur day(s) prior to, during and after the actual event.

The Volunteer and Guardian do hereby freely, voluntarily, and without duress execute this Release under the following Terms:

1. **Release and Waiver.** Volunteer and Guardian do hereby release and forever discharge and hold harmless SoBo Central and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with SoBo Central.

Volunteer and Guardian understand that this Release discharges SoBo Central from any liability or claim that the Volunteer or Guardian may have against SoBo Central with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with SoBo Central, whether caused by the negligence of SoBo Central or its officers, directors, employees, or agents or otherwise. Volunteer and Guardian also understand that SoBo Central does not assume any responsibility for or obligation to provide financial or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. **Medical Treatment.** Volunteer and Guardian do hereby release and forever discharge SoBo Central from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with SoBo Central or with the decision by any representative or agent of SoBo Central.
3. **Assumption of Risk.** The Volunteer and Guardian understand that the Activities may include work that may be hazardous to the Volunteer, including, but not limited to, loading and unloading, and transportation to and from the event site.

Volunteer and Guardian hereby expressly and specifically assume the risk of injury or harm in the Activities and release SoBo Central from all liability for injury, illness, death, or property damage resulting from the Activities.

4. **Insurance.** The Volunteer and Guardian understand that, except as otherwise agreed to by SoBo Central in writing, SoBo Central does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

5. **Photographic Release.** Volunteer and Guardian do hereby grant and convey unto SoBo Central all right, title, and interest in any and all photographic images and video or audio recordings made by SoBo Central during the Volunteer's Activities with SoBo Central, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. **Other.** Volunteer and Guardian expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Maine and that this Release shall be governed by and interpreted in accordance with the laws of the State of Maine. Volunteer and Guardian agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
